From the Minister...

*“I lift up my eyes to the hills— from where will my help come?
My help comes from the Lord, who made heaven and earth.” Psalm 121: 1-2*

What a year 2020 has been! It was not a year any of us expected and it changed the way we have lived, worked, and worshiped. We have needed the words of Psalm 121 more than ever.

The year began well with a baptism and a great team of walkers, well-supported by the congregation, for the Coldest Night of the Year in support of the Alliston Out of the Cold program. We had our Annual Meeting and had just begun a Lenten series called ‘The Grace of Les Miserables’ when everything came to a standstill.

We found ourselves in a global pandemic and were told to stay home to stop the spread of Covid-19. I think we all thought things would get back to normal within a month, but as the weeks went on, it became apparent we would have to adapt the way we lived and the way we worshiped.

In collaboration with Living Faith in Baxter, we began producing videos for each Sunday which were uploaded to YouTube and on our website. We found new ways to connect using technology like Zoom for online meetings. As we quarantined at home, we all tried to cope the best we could. Maybe you tried new recipes, maybe you completed puzzles, maybe you read books you hadn’t had time for before, maybe you learned how to ‘do school’ from home, maybe you tried online shopping for the first time.

As time passed, we had to cancel all the usual events of the church like our suppers, the annual picnic, and the Christmas bazaar. When restrictions eased in the fall, we worked out a plan to safely worship in-person with distanced seating, masks on, and no singing in worship. It was strange, but nice to finally see each other again. As it became apparent the second wave of the virus was worsening, we went to online worship again including Christmas Eve.

I give thanks for our Session and Board of Managers, and our staff who have all had to adjust and try new ways of doing things. Financially, the church has stayed in a solid position thanks to your amazing generosity and with the help of government subsidies.

I know it has been a difficult year not to worship and fellowship together, but I have no doubt that God is with us, has been with us every day and will continue to be with us. As we carry on in these challenging times in 2021, we look forward to the day when we can worship and praise God together. In the meantime, stay safe, stay connected to each other, and seek help from “the Lord who made heaven and earth.”

SESSION REPORT

As I start to write this report, may we try to look forward and not back. The year 2020 was a really hard time for us all. It was something I have never experienced and I hope it will soon be over.

Even though things were different this year, we still continued as a congregation.

Communion was held February 2nd and November 29th, with members, adherents and children taking part. Logan, son of Angela Yoon and Pedro Laranjeira and Caleb, son of Danielle (Daughter of Dan Jones) and Matthew Poremba were baptized in 2020.

At our Annual Meeting, Knox congregation accepted \$21,000.00 to Presbyterians Sharing. We installed a new sound system and also purchased a new camera to help with the online worship services. Through ballots, the congregation voted in favour of paving the church parking lot.

The church was closed in March due to the pandemic. In July, protocols were set up to re-open the church. Sunday, September 6th was the first Sunday back and Rev. Tobey sent out a letter to congregation by mail and email to let everyone know. There were many rules that we, as a congregation, had to follow to keep safe.

There was no special Anniversary Speaker this year and our Christmas Eve Service was online in 2020.

Our Christmas projects were a little different this year and we gave \$1,000.00 to The Lions Club, Out of the Cold, and The Food Bank as well as gift cards to My Sister's Place for three sponsored families.

Barbara Hustler retired as Knox Secretary with her last day being December 31, 2020. She will be missed but we hope she enjoys her retirement. Samantha Kamminga, our CE Coordinator, has taken on the responsibility of secretary as well.

We have lost nine of our members in 2020: Ethel Petersen, Kay and Earl Lowe, Lorne Burbidge, Pat Friesen, Bert Hoferichter, Jack MacMurchy, Bob Linton and Dick Mawdsley. They will be missed so much and because of Covid 19, many of us couldn't even give our condolences to their families in person. As we begin a new year, our church is closed again as we continue watching our services Online. I hope you are all able to watch the services. Rev. Tobey is working hard to keep us together and is doing a great job. So my prayer is that you all stay healthy and safe. If anyone needs help, please reach out to anyone of us. May God be with you all.

TRUSTEE REPORT

The Trustees continue to monitor the insurance needs of the church and church activities. We insure our building and contents are properly insured and that our liability policy is sufficient to cover any claims.

Thanks to the generous financial support from our Church family and the government assistance we received through the CEWS (Canada Emergency Wage Subsidy) program, we have not needed to access money from the Trustee account to support the General Fund account to cover church costs. Thanks also to our Board of Managers for their continuing efforts to control expenses.

We ask God's blessing and direction as we proceed in the new year.

We postponed having the parking lot re-done in the fall. We have selected a company and they are holding their price for us so we can take care of this in the spring.

On the subject of the parking lot, we had signed with last year's plowing company but due to extreme insurance costs he could no longer offer his services. After talking to all plowing companies in the area, we found only one that was willing to take on our contract. We quickly discovered that with the new pressures of insurance we could not afford all the salting services required while the church was not being used. We thus altered the contract and have closed off our parking lot to all but our staff for the moment. We are sorry for any inconvenience this causes. We will begin researching future options.

We have been working to maintain our building and equipment through this time and are monitoring all the utilities such as water, electricity and heating systems, ensuring we have decreased all usage while things are not required.

The board can't thank Rev. Tobey enough for her leadership and support throughout this time. We pray that we can soon spend time together and these troubles will decrease. May God protect you all until we see each other again.
